School launches mask project

Fundraiser will help buy computers and more

As Theresa "Teecy" Matthews walks through the computer lab at Ocali Charter Middle School, she pauses and, with her hands spaced apart in the air, presents the modest collection of refurbished Dell laptops.

Matthews, the school's administrator, explains that there are only 40 laptops for the 150 sixth-through eighth-grade students to share.

"This is their world, technology. We're really hoping to bring ourselves up into 2017. We need more laptops, desktops and Wi-Fi that reaches the entire perimeter of the school. Students often must complete technology-based assignments at home. We want them to do the work here," Matthews said.

Matthews' positive and proactive approach to her school's technology challenge led to the creation of the Faces of Ocala Community Mask Project. The collaborative art project unites community members and businesses with Ocali students and local artists.

"The concept behind it was to involve the children in their art and provide an opportunity

for folks to see the work that our kids are doing," Matthews said.

For a minimum \$250 donation, an Ocali Charter student, or a local artist selected by the sponsor, will design and paint a ceramic mask in the studios at Picasso's Palette, one of the sponsors of the project.

The completed masks will be displayed at various locations in Ocala. There also is an online auction through which to bid on completed masks. Each sponsor will receive two tickets to a May 4 Faces of Ocala luncheon, during which sponsors and benefactors will be recognized.

"Guest speakers will discuss changing the face of education and why that's so key-critical, especially in the world that we live in," Mat-

thews said.

"Now, all the kids have to say is 'OK Google' and they can get knowledge. Teachers are becoming more facilitators and teach how to implement knowledge, how to use knowledge, how to make knowledge relevant to what they're doing, and that's the transition that our school is trying to take and model, not statewide," she added.

Eighth-grader Hunter Moore smiled as he held his completed American flag inspired mask for the

first time.

"I didn't think I was learning space. going to see it when it was done," he said. "I think the project is cool. I've never been in a fundraiser and I like art."

"Everybody is gifted in some way and these kids get to identify what they are going to do. This is actually a new approach that we're implementing to help increase motivation, so you get only for our district, but your tasks done, you can work on something you're really interested in," Matthews explained while walking through a large cafeteria which serves as the common
